AMENDMENT NO. 1
SERVICE AGREEMENT
WITH
ON ASSIGNMENT STAFFING SERVICES, LLC DBA LAB SUPPORT
(Contract No. C-10591)

This Amendment No. 1 ("Amendment") to the Service Agreement ("Agreement") is made this 26 day of April, 2016, ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and On Assignment Staffing Services, LLC, dba Lab Support, a Delaware limited liability company authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and On Assignment Staffing Services, LLC dba Lab Support ("Contractor") previously entered into Service Agreement with On Assignment Staffing Services, LLC dba Lab Support, Contract No. C-10591, dated January 20, 2016 ("Agreement"); and
- B. The Service Agreement had an initial term through April 30, 2016; and
- C. The Service Agreement is being extended based on mutual written agreement of the parties; and
- D. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
2. **Term.** The term of the Agreement is extended from May 1, 2016 through September 30, 2016, unless otherwise terminated or canceled as provided by the Agreement. All other provisions of the Agreement except as set forth in this Amendment shall remain in their entirety.
3. **Scope of Work.** The Scope of Work remains unchanged.
4. **Compensation.** Contractor's compensation is changed to an amount not to exceed \$82,000.

5. **Insurance Certificate.** Current certificate will expire on October 1, 2016 and a new certificate applying to the extended term must be provided prior to this date to Materials Management and the Contract Administrator.
6. **Non-discrimination.** Contractor must not discriminate against any employee or applicant for employment on the basis of race, color, religion, sex, national origin, age, marital status, sexual orientation, gender identity or expression, genetic characteristics, familial status, U.S. military veteran status or any disability. Contractor will require any Sub-contractor to be bound to the same requirements as stated within this section. Contractor, and on behalf of any subcontractors, warrants compliance with this section.
7. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.


