AMENDMENT NO. 5

PRINTING OF THE WATER BILLS SERVICE
AGREEMENT (RFP 09-20 Contract No. C-7105)

This Amendment No. 5 ("Amendment") for Printing of the Water Bills Service Agreement is made to be effective the 27th day of October, 2014 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and InfoSend, Inc. ("Contractor").

RECITALS

- A. City and Contractor previously entered into a Printing of the Water Bills Service Agreement, Contract No. C-7105, dated October 27, 2009 ("Agreement"); and
- B. The Agreement had an initial one-year term beginning October 27, 2009 through October 26, 2010 and provided the option to extend the term for an additional five (5) years in one-year increments; and
- C. City and Contractor previously entered into Amendment No. 1, extending the term of the Agreement from October 27, 2010 through October 26, 2011; and
- D. City and Contractor previously amended the Agreement, extending the term of the Agreement from October 27, 2011 through October 26, 2012; and
- E. City and Contractor previously amended the Agreement, extending the term of the Agreement from October 27, 2012 through October 26, 2013; and
- F. City and Contractor previously amended the Agreement, extending the term of the Agreement from October 27, 2013 through October 26, 2014.
- G. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.


AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.

2. **Term.** The term of the Agreement is extended for a one-year period from October 27, 2014 through October 26, 2015, unless terminated or canceled as provided within the Agreement. All other provisions of the Agreement shall remain in their entirety.
3. **Scope of Work.** The Scope of Work is unchanged.
4. **Compensation.** Contractor's compensation is amended as of April 1, 2015 and Exhibit B of the original Agreement is amended as set forth in Exhibit B-Amendment No. 5, attached hereto. The compensation of the Agreement is not to exceed \$135,000 for the new term.
5. **Insurance Certificate.** The existing insurance certificate is expiring and a new certificate applying to the extended term is required and must be received by the Contract Specialist prior to the execution of this Amendment.
6. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.


