**Amendment No. One (1) to the 2011-12  
Independent Contractor Agreement  
Contract No. 07012011-12**

The Independent Contractor Agreement dated September 13, 2011 between The Arizona Community Action Association, Inc. (ACAA) and **City of Glendale, an Arizona municipal corporation, through its Community Action Program** (hereinafter "Contractor") to conduct application intake and eligibility determination for utility bill assistance is amended as follows:

**Purpose of the Amendment:**

To allocate additional Salt River Project (SRP) Bill Assistance funds in the amount of **\$5,000.00** (\$4,545.00 for direct service and \$455.00 for program delivery) to provide utility bill assistance to eligible SRP customers.

To decrease the Utility Repair Replace and Deposit Program by the amount of **\$35,000.00** (\$32,407.00 from direct service, and \$2,593.00 from program delivery).

**Amendment to:**

Section 1. Services and Programs – 1.2 Fund Sources:

**SRP Bill Assistance Fund Source:** Increase direct service dollars from \$34,920.90 to \$39,465.90, and program delivery dollars from \$3,492.10 to \$3,947.10. The total amount of SRP Bill Assistance increased from \$38,413.00 to \$43,413.00.

**URRD Fund Source:** Decrease direct service dollars from \$66,683.33 to \$34,276.33 and program delivery dollars from \$5,334.67 to \$2,741.67. The total amount of URRD funds decreased from \$72,018.00 to \$37,018.00.

**Whole Agreement:**

Unless otherwise noted herein, all other provisions of the original Independent Contractor Agreement will remain in place for the duration of the original Agreement.
