Contract Amendment No. Four (4) RFP # 08-22 Sports Officiating Services November 2011

In accordance with the Special Terms and Conditions, the above referenced contract is amended as follows:

The option to extend the term of the agreement is exercised this 10th day of November 2011. The term of the contract is hereby extended from January 1, 2012 through December 31, 2012, unless terminated, canceled or extended as provided within the contract.

A price increase to \$22.50 per game for officials shall be implemented beginning with this agreement.

It is the intent of the City of Glendale to contract for professional officiating services for adult, teen and senior slow pitch softball ball games to be played between December 16, 2011 and December 15, 2012.

Proposer shall be able to provide an appropriate number of softball umpires for approximately 6 game sites and for approximately 3,024 games per year.
