## SUBRECIPIENT CONTRACT - NONPROFIT CORPORATIONS

CITY OF GLENDALE, ARIZONA

EMERGENCY SHELTER GRANTS

FY 2011-2012

This Subrecipient Contract ("Contract") is executed this 1st day of July, 2011, by and between A New Leaf, Inc., an Arizona nonprofit corporation ("Agency"), and the City of Glendale, an Arizona municipal corporation ("City"). The parties hereby agree as follows:

**1. Contract Amount:**

1.1 The Agency will furnish all labor, materials, services, supervision, tools, equipment, licenses, and permits necessary to operate the Faith House Emergency Shelter Operations ("**Program**") as defined by the Scope of Services attached as **Exhibit A**.

1.2 The City will provide financial assistance in an amount not to exceed \$33,166.00. This Contract price constitutes the entire consideration for the City's participation in the performance and completion of all work to be performed under this Contract.

**2. Contract Term:** Contract will be effective July 1, 2011 and terminate on June 30, 2012.

**3. Commitment of Match:** The Agency agrees to make a match toward the Program. The commitment of match is for the amount of \$33,364.00 as defined by the Match Letter attached as **Exhibit B**.

**4. Method of Payment:** Payment will be made in such amounts and increments as may be approved by the City for various phases of work upon submission of a proper request for payment, including supporting documentation. See **Exhibit C** for billing and reporting information. The final request for payment will be submitted to the City within 15 days after expiration or termination of this Contract.

**5. Program Income:** Any Program Income, as defined in 24 CFR § 570.500(a), received by the Agency prior to grant close-out will be used to offset payment due in an amount directly proportional to the prorated share of Emergency Shelter Grant ("ESG") funds used as set forth in 24 CFR § 570.504(c). Under this Contract, "Program Income" refers solely to those funds derived from the Agency provided in the City of Glendale and includes, but is not limited to income received from the clients served for services performed or materials purchased. Documentation supporting the amount of Program Income received will be submitted with monthly billings.

**6. The City Certifies:**

6.1 The services/project described by the Agency to be provided will principally benefit low and moderate-income persons within the community.

6.2 That the public purpose is served by the financial participation of the City in the above-referenced service.

6.3 That the ESG funds designated for the Program constitute reasonable and prudent assistance necessary for the completion of the Program.

**7. The Agency Certifies:**

7.1 That it is an Arizona nonprofit corporation.

7.2 That it intends to provide the service for which funds are granted under this Contract for at least one year.

7.3 That it possesses legal authority to execute this Contract.

- 7.4 That its governing body has duly adopted or passed as an official act, a resolution, motion, or similar action authorizing the person identified as the official representative of the Agency to execute this Contract and to comply with the terms of this Contract.
- 7.5 That the services will be carried out and administered in compliance with all federal laws and regulations as further described in **Exhibit D**.
- 7.6 That the Program assisted under this Contract is designed to give maximum feasible priority to activities that benefit low and moderate-income families as defined in **Exhibit E**.
- 7.7 That if applicable, it will comply with the City's procurement, mediation and right of refusal clauses as described in **Exhibit F**.
- 7.8 That it will comply with all applicable laws.

**8. The City Agrees To:**

- 8.1. Disburse funds in a timely manner as described in this Contract.
- 8.2 Provide technical assistance to the Agency to comply with applicable federal provisions governing the use of ESG funds.
- 8.3 Complete all environmental review requirements as described in 24 CFR Part 58.

**9. The Agency Agrees To:**

- 9.1 Activities. Utilize normal and customary practices and procedures for the delivery of the Agency services/project, and provide a level of service that is consistent with the level of service for similar activities administered by the Agency exclusive of this Contract as defined by the Scope of Services attached in **Exhibit A**.
- 9.2 Record Retention. Retain all records pertinent to expenditures incurred under this Contract for a period of six years from the date of the submission of the City's annual performance and evaluation report in which the specific activity is reported on for the final time. Records for non-expendable property acquired with funds under this Contract will be retained for six years after final disposition of such property. Records for any displaced person must be kept for six years after receipt of final payment. Notwithstanding the above, if there is litigation, claims, audits, negotiations or other actions that involve any of the records cited and that have started before the expiration of the six year period, then such records must be retained until completion of the actions and resolution of all issues, or the expiration of the six year period, whichever occurs later.
- 9.3 Uniform Administrative Requirements. Comply with the requirements and standards of OMB Circular No. A-122, "Cost Principles for Non-Profit Organizations." Establish and/or maintain accounting systems that meet the requirements for OMB Circular A-110 "Uniform Administrative Requirements for Grants and Contracts with Institutions of Higher Education, Hospitals, and Other Non-Profit Organizations." Comply with the audit requirements of the Single Audit Act Amendments of 1996, and OMB Circular A-133, "Audits of States, Local Governments, and Non-Profit Organizations." Compliance with these requirements will be subject to monitoring from time to time by the City or by the Department of Housing and Urban Development ("HUD").
- 9.4 Recordkeeping Requirements. Keep records of ethnic and racial statistics of all persons and families benefited by its services including, but not limited to, the number of low and moderate income persons assisted in accordance with federal income limits, the number of elderly and disabled, family size, and the number of female heads of household. The Agency agrees to provide the City with monthly written progress reports of its activities no later than the 15th of each month that follows the month that activities being reported/billed until such time as this Contract expires. The Agency also agrees to submit on the 15th of

July, 2012, a comprehensive report covering the agreed-upon objectives, activities, and expenditures for the fiscal year.

- 9.5 Access to Records. The City and HUD and/or their representatives will have access for purposes of monitoring, auditing, and examining performance to all pertinent books, documents and papers. However, nothing herein will be construed to require access to any privileged or confidential information as set forth in federal or state law.
- 9.6 Emergency Shelter Grants Program. Incorporated into subtitle B of IV of the Stewart B. McKinney-Vento Homeless Assistance Act (42 U.S.C. §§ 11371-11378) ("Act") to acknowledge that the funds being provided by the City for said program are received by the City pursuant to Title 42 of the U.S. Code, as well as parts of Title 24 of the Code of Federal Regulations, and that expenditures of these funds will be in accordance with Program related laws and with all pertinent regulations issued by agencies of the federal government. The Agency agrees to comply fully with all federal, state and local laws and court orders applicable to its operation whether or not referred to in this Contract.
- 9.7 Independent Contractor. Acknowledges that the performance of obligations hereunder by an independent contractor is rendered in its capacity as an independent contractor and that it is in no way an agent of the City.
- 9.8 Indemnification and Hold Harmless. Indemnify, defend and hold harmless the City, and its officers, agents and employees, hereinafter collectively referred to as City, from all claims and suits, including attorneys' fees and costs of litigation, actions, loss, damage, expense, costs or claims, of any character or any nature arising out of any act, omission or work done in fulfillment of the terms of this Contract or an account of any act, omission, claim or amount arising or recovered under Workmen's Compensation Law, or arising out of the failure of the Agency or those acting under the Agency to conform to any statutes, ordinances, regulations, law or court decree. It is the intent of the parties to this Contract that the City will, in all instances, except for loss or damage resulting from the sole negligence of the City, be indemnified against all liability, loss or damage of any nature whatever for or on account of any injuries to or death of person or damages to or destruction of property belonging to any person arising out of or in any way connected with the performance of this Contract, regardless of whether or not the liability, loss or damage is caused in part by, or alleged to be caused in part by, but not solely, the negligence or fault of the City. It is agreed that the Agency will be responsible for primary loss investigation, defense and judgment costs where this Contract of indemnity applies.
- 9.9 Insurance. Will provide evidence of insurance in accordance with the request for proposals, as shown in **Exhibit G**. The City will be named by the insurer as an additional insured on all required insurance for all operations performed within the scope of this Contract. All certificates of insurance must provide for thirty-day notice to the City of cancellation, nonrenewal or material change.

#### 10. **Compliance with Laws:**

- 10.1 The Agency will comply with all applicable federal, state and local laws, statutes, ordinances, administrative rules, building codes, regulations and lawful orders of any public authority bearing on the performance of activities pursuant to this Contract. If the Agency discovers that any of the Contract documents are in conflict with any laws, statutes, ordinances, rules, building codes, regulations or lawful orders of a public authority, the Agency will promptly notify the City, in writing, of such conflict, specifying any necessary changes to the Contract documents or work to eliminate the conflict.
- 10.2 The Agency, and its subcontractors, will abide by all regulations pursuant to the Immigration and Naturalization Reform Act of 1986, specifically as it relates to employment and client services, and such other provisions as may be applicable. Should the Agency perform any

work knowing it to be contrary to the applicable laws, ordinances, rules, building codes and/or regulations, and not give proper notice to the City, it will assume full responsibility, therefore, and will bear all cost incurred due to its negligence. Any dispute not disposed of by mutual contract by the parties hereto will be decided in accordance with the applicable Arizona laws, ordinances, codes of the state and local governments.

- 10.3 The Agency will comply with and require all subcontractors paid with funds provided by this Contract to comply with all of the applicable provisions of the Housing and Community Development Act of 1974, as amended, 24 CFR Part 570, and the Special Conditions for activities assisted pursuant to Title I of the Community Development Act of 1974.
11. **Availability of Funds:** It is expressly understood by the parties hereto that this Contract has been negotiated and executed in anticipation of receipt of funds by the City from HUD pursuant to the ESG Program and that therefore, the terms, conditions and sums payable under this Contract are subject to any changes or limitations which may be required by the terms of said grant contract.
12. **Reversion of Assets:** The Agency will forfeit to the City, upon expiration or termination of this Contract, any ESG funds remaining and any accounts receivable attributable to the use of ESG funds, including Program Income.
13. **Acknowledgment:** The Agency will acknowledge the contribution of the City's ESG Program in all published literature, brochures, programs, fliers, etc., during the term of the Contract.
14. **Certifications:** The Agency agrees to sign the following Certifications which are attached as **Exhibit H:**
  - 14.1 Policy of Nondiscrimination on the Basis of Disability.
  - 14.2 Anti-Lobbying, Section 319 of Public Law 101-121.
  - 14.3 Contracting with Small and Minority Firms, Women's Business Enterprises and Labor Surplus Area Firms.
  - 14.4 Drug-Free Workplace Act of 1988.
15. **Non-Discrimination:** The Agency will not discriminate against any applicant for employment or service, or any employee of the Agency on the basis of race, color, religion, sex, national origin, age or disability. The Agency will take affirmative steps to ensure that employees, applicants for employment and applicants for service are treated without regard to race, color, religion, sex, national origin, age or disability. The Agency will post in a conspicuous place available to employees and the public, notices setting forth the provisions of this non-discrimination clause. The Agency will, in all solicitations or advertisements, state that all qualified applicants will receive consideration for employment or service without regard to race, color, religion, sex, national origin, age or disability.
16. **Immigration Compliance:**
  - 16.1 The Agency, and on behalf of any sub-contractor, warrants, to the extent applicable under A.R.S. § 41-4401, compliance with all federal immigration laws and regulations that relate to their employees as well as compliance with A.R.S. § 23-214(A) which requires registration and participation with the E-Verify Program.
  - 16.2 Any breach of warranty under this section is considered a material breach of this Contract and is subject to penalties up to and including termination of this Contract.
  - 16.3 The City retains the legal right to inspect the papers of the Agency or sub-contractor employee who performs work under this Contract to ensure that the Agency or any sub-contractor is compliant with the warranty under this section.
  - 16.4 The City may conduct random inspections, and upon request of the City, the Agency will provide copies of papers and records of the Agency demonstrating continued compliance

with the warranty under this section. The Agency agrees to keep papers and records available for inspection by the City during normal business hours and will cooperate with the City in exercise of its statutory duties and not deny access to its business premises or applicable papers or records for the purposes of enforcement of this section.

- 16.5 The Agency agrees to incorporate into any subcontracts under this Contract the same obligations imposed upon the Agency and expressly accrue those obligations directly to the benefit of the City. The Agency also agrees to require any sub-contractor to incorporate into each of its own subcontracts under this Contract the same obligations above and expressly accrue those obligations to the benefit of the City.
- 16.6 The Agency's warranty and obligations under this section to the City is continuing throughout the term of this Contract or until such time as the City determines, in its sole discretion, that Arizona law has been modified in that compliance with this section is no longer a requirement.
- 16.7 The "E-Verify Program" above means the employment verification program administered by the United States Department of Homeland Security, the Social Security Administration, or any successor program.
17. **Prohibitions:** The Agency certifies under A.R.S. §§ 35-391 *et seq.* and 35-393 *et seq.*, that it does not have, and during the term of this Contract will not have, "scrutinized" business operations, as defined in the preceding statutory sections, in the countries of Sudan or Iran.
18. **Termination:**
  - 18.1 In accordance with 24 CFR § 85.43, the City may suspend or terminate this Contract if the Agency violates any term or condition of this Contract or if the Agency fails to maintain a good faith effort to carry out the purpose of this Contract.
  - 18.2 Since the Agency's performance in furtherance of this Contract is also the consideration offered under this Contract, the Agency's failure to comply with each and every term and condition hereunder may result in immediate termination of the Contract and a refund of the weekly (or monthly, in the City's sole discretion) pro-rated amount of the previously tendered ESG or other grant funds.
  - 18.3 Notwithstanding this section, the City's decision to waive or defer compliance with any term or condition of the Agency's required performance under this Contract does not act, nor will it be deemed or interpreted as, a waiver or deferment of the City's right to terminate and to receive its refund based upon the Agency's non-compliance with other terms or conditions of this Contract or subsequent non-compliance with the same terms and conditions.
  - 18.4 The City or the Agency may terminate this Contract for convenience. Both parties will agree upon the termination conditions. The party initiating the termination will notify the other party in writing stating the reasons for such termination. The terminating party will give thirty days prior notice.
  - 18.5 This Contract is subject to the provisions of A.R.S. § 38-511 and may be canceled, without penalty or further obligation, by the City if any person significantly involved in initiating, negotiating, securing, drafting or creating this Contract on behalf of the City is, at any time while this Contract or any extension of this Contract is in effect, an employee or agent of any other party to this Contract in any capacity or consultant to any other party of this Contract with respect to the subject matter of this Contract.
19. **General Provisions:**
  - 19.1 It is hereby agreed that subsequent to the execution of this Contract, the Community Revitalization Division of the City of Glendale will represent the City in the administration

of this Contract. All notices required or permitted to be given under this Contract may be personally delivered or mailed by certified mail, return receipt requested, postage prepaid, to the following addresses:

- 19.2 Both parties acknowledge that no member of the governing body of the City or any employee of the City who exercises any functions or responsibilities in connection with the carrying out of the Program to which this Contract pertains has any personal interest direct or indirect in this Contract.
- 19.3 This Contract supersedes any and all other contracts, either oral or in writing, between the parties hereto and contains all the covenants and contracts between the parties with respect to such employment in any manner whatsoever. Each party to this Contract acknowledges that no representations, inducements, promises or contracts, orally or otherwise, have been made by any party, or anyone acting on behalf of any party, which are not embodied herein, and that no other contract or amendment hereto will be effective unless executed in writing and signed by both the City and the Agency.
- 19.4 This Contract will be governed by and construed in accordance with the laws of the State of Arizona and all applicable federal laws and regulations.
- 19.5 The invalidity in whole or in part of any provision of this Contract will not void or affect the validity of any other provision of this Contract.



**EXHIBIT "A"**

**EXHIBIT A**  
**SCOPE OF SERVICES**

1. The Scope of Services and the type of records that must be maintained are two elements of a Subrecipient Contract that vary most from activity to activity, and from grantee to grantee.
2. Agencies are required to prepare a Scope of Services, which is incorporated into the Subrecipient Contract with the City of Glendale. Each of the three sections of the Scope of Services (Description, Schedule, and Budget) must provide sufficient detail to permit effective monitoring of Agency's activities.
  - 2.1 Description: The description section details the activities to be carried out by the Agency. It should define the "who, what, where, and how" of the Program. It should specifically describe and quantify the services or products to be provided with City of Glendale funds. Where appropriate, it should specify how the Program will serve the intended beneficiaries.
  - 2.2 Schedule: A schedule is a required part of every Subrecipient Contract. It plays an essential role in the grant management system. The schedule should provide projected milestones and deadlines for accomplishment of tasks, or the delivery of services. These projected milestones and deadlines are a basis for measuring progress during the term of the Subrecipient Contract. For instance, the schedule for a public service activity may specify delivery of a certain number of staff-hours per quarter, or delivery of services to a certain number of persons per quarter. Other programs are likely to be more complex, requiring multiple tasks such as: establishing an office, developing program guidelines, taking applications, providing services to the client, outreach activities, and follow up. The schedule should include time frames for completing each task or activity.
  - 2.3 Budget:
    - a. The budget should provide a detailed presentation of projected revenues and expenses. The preparation of a detailed budget will help ensure that a project is adequately planned, in that, it will identify all expenses that are necessary to carry out the activities described in the program description, and quantify the resources required to cover these expenses.
    - b. The budget permits periodic comparisons of the projected use of funds with actual expenditures, as indicated on the monthly accomplishment reports submitted by the grantee. This comparison enables the City to seek corrective action where significant variations between the budget and actual expenditures are reported.

## Scope of Service FY 2011-2012

### A. Program Activity

**A New Leaf, Inc.** ("Agency") will be responsible for administering **Faith House Emergency Shelter Operations** ("Program") in a manner satisfactory to the City of Glendale ("City"), and consistent with any standards required by Emergency Shelter Grants ("ESG") as a condition of providing these funds. The Program will include the following eligible activities:

Activity #1 Provide services to 16 women & children

The Program offers shelter, crisis intervention, and support services that help battered women and their children to live free from family violence. By providing immediate, daily crisis counseling, and up to 120 days of shelter care, the Program serves as a means for victims of domestic violence to feel protected and supported while they begin the process of rebuilding their lives. The Agency is staffed 24-hours a day by trained Program Support Partners. The staff helps to problem solve as a role model, advocate, educate and support clients in achieving their service goals. All physical requirements of shelter, food, and safety are ensured for the duration of each client's stay.

Activity #2 Provide 2,160 staff hours quarterly

The Program Support Partners fulfill a variety of duties in assisting with clients' needs and the programs round-the-clock operations. Their job duties include conducting intakes and assisting with client discharge, answering the shelter's telephone lines, assisting clients in accessing community and other services, helping to facilitate groups, providing advocacy and crisis intervention to clients, and modeling appropriate assertiveness and parenting skills. Program Support Partners also assist with case management, keeping detailed progress notes on each client and attending regular staff meetings and focus meetings. They function in endless ways to address the many needs that clients in crisis may have.

Activity #3 Conduct client intakes as needed

Once a client is admitted to the program, a Program Support Partner conducts an in-person intake interview at the facility within 24 hours, including an initial behavioral health and medical questionnaire, exploration of personal resources, program orientation, and identification of any community resources they may need. The Program Manager, Program Supervisor and/or Case Manager review all intake files within 48 hours of admission to ensure all documentation is complete.

Activity #4 Complete Individual Service Plans within 72 hours of program admission

Upon admission to the Agency, a Case Manager interviews the client, assesses their immediate needs and obtains general information as to what a client would like to accomplish while in shelter. The shelter service coordinator will then initiate a formal written service plan. The service plan will be revised and updated as needed during the term of the service.

Activity #5 Provide advocacy, support and group sessions

Advocacy services are essential to any shelter service operation. Most people in crisis need assistance in improving decision-making processes and rational thinking that is in the best interest of their loved ones, including themselves. The survival instinct usually takes over, which for the domestic violence victim often means staying in an abusive situation because other choices do not seem apparent. Taking steps to leave may place the victim at greater risk for more violence.

Clients attend group sessions which assist them to accomplish their goals. Sessions include assertiveness skills training, self esteem enhancement exercises, stress reduction exercises, conflict resolution exercises, problem solving, parenting skills, communication skills, understanding healthy boundaries and exploring the healthy expression of feelings. The Program provides the advocacy and life skills victims need to end the cycle of violence and build on the courage it took to leave and not return.

Activity #6 Provide community resource and referral

in

Program Support Partners, through referrals and advocacy, routinely assist Case Managers helping clients to obtain all of the services they need both during their Program participation, including housing, food stamps, transportation, employment, medical and child care, etc. as identified in the individual service plan. The Program maintains a cooperative relationship with both domestic violence and other homeless transitional living programs, allowing clients in need of continued support to get immediate help. Staff members provide advocacy services for residents in need of support in dealing with the police, courts or government agencies.

Activity #7 Conduct customer satisfaction surveys quarterly

Client satisfaction surveys are administered to all clients during the quarter they exit the program. These results are tabulated and entered in to the database. The Program Manager and Executive Vice President of Emergency and Shelter Services analyze these results and provide them to funding sources as required. In addition, results from the client satisfaction survey are reviewed with program staff to enhance program services where needed as well as make necessary improvements.

Activity #8 Tabulate and monitor program outcomes

Indicator data is collected and measured by conducting a client record audit. This data is entered into a database and tabulated on a monthly basis for all clients exiting the Program. Quarterly and yearly totals are tracked and reported to funding sources as required to determine success.

A self-report (follow-up) survey is administered to all clients every 30 days. Those surveys that are returned will have their results tabulated and entered into the database. Results are analyzed by the Program Manager and Executive Vice President of Emergency and Shelter Services.

Activity #9 General Program Administration

Each staff member is responsible for documenting all client contact in the individual files at the end of each shift. The Program Manager and Program Supervisor review client files and individual service plans monthly to monitor service delivery. In addition, each client's progress is reviewed weekly by all personnel during case staffing meetings, then recorded, reviewed by the client, signed, and filed within 72 hours. Specific referrals given to the client are recorded and filed. Service plans developed by the client, Case Manager and Lead Service Coordinator are filed in the client's folder, reviewed by all staff and signed by the Program Supervisor. All group sessions are recorded by the Lead Shelter Service Coordinator, reviewed by the Supervisor and filed in the client's file.

Staff must also report any unusual behaviors or circumstances including all emergency contacts, and document them in the client's file as well. Emergency staff is held as needed, and the Program Manager and Program Supervisor are available via cell phone 24 hours daily.

B. National Objectives

Eligible Activity:

All activities funded with ESG funds must meet one of the ESG Program’s National Objectives:

- NATIONAL OBJECTIVE #1 – To increase the number and quality of emergency shelters and transitional housing facilities.
- NATIONAL OBJECTIVE #2 – Operation of emergency shelters or transitional housing facilities.
- NATIONAL OBJECTIVE #3 – Provide essential social services to prevent homelessness.

The Agency certifies that the activity carried out under this Agreement will meet National Objective 1.

This National Objective will be met by serving women and children who need advocacy, shelter, case management, and counseling due to living with family violence. All individuals in this target group are considered homeless because of financial deprivation, victimization or exploitation, and over 90% live at least 80% below the Area Median Income level of the service area. The funding received from the City of Glendale ESG funds will assist low and moderate income Glendale residents.

C. Levels of Accomplishment – Goals and Performance Measures

The levels of accomplishment may include such measures as units rehabbed, persons assisted, or meals served, and should also include time frames for performance.

The City will monitor the performance of the Agency against goals and performance standards, as stated above. Substandard performance, as determined by the City, will constitute non-compliance with this Agreement. If action to correct such substandard performance is not taken by the Agency within a reasonable period of time, after being notified by the City, Contract suspension or termination procedures will be initiated.

D. Time of Performance

The Agency services shall begin on the 1st day of July, 2011, and shall end on the 30th day of June, 2012.

Income is determined through completion of the intake application which requires a participant to disclose annual income and family size. This information is then used to determine their income status. Program data indicates that 100% of individuals served at the Faith House shelter meet the low to moderate income requirement.

- Glendale residency will be documented by:

The percentage of Glendale residents is calculated by dividing the number of participants that identified themselves as Glendale residents at admission by the total number of program participants. The number of Glendale residents is determined by collecting pertinent demographic data at admission. This information is entered on an intake screening form using client management software called Pro-filer. This client management software is able to store and retrieve this information including the city of residence for program participants.

  5. **Interest of Members, Officers or Employees of the Agency, Members of Local Governing Body, or Other Public Officials.** No member, officer, or employee of the Agency or its designees or agents, no member of the governing body of the locality in which the program is situated, and no other public official of such locality or localities who exercises any functions or responsibilities with respect to the program during his tenure or for one year thereafter, will have any interest, direct or indirect, in any contract or subcontract, or the proceeds thereof, for work to be performed in connection with the program assisted under this Contract.
  6. **Hatch Act.** The Agency agrees to comply with all provisions of the Hatch Act and that no part of the program will involve political activities, nor will personnel employed in the administration of the program be engaged in activities in contravention of Title V, Chapter 15, of the United States Code.

- c. A stipulation that as a condition for the award of the contract, prompt notice will be given of any notification received from the director, Office of Federal Activities EPA, indicating that a facility utilized or to be utilized for the contract is under consideration to be listed on the EPA list of Violating Facilities.
  - d. Agreement by the contractor that he will include or cause to be included the criteria and requirements in paragraphs (a) through (d) of this section in every nonexempt subcontract and requiring the contractor to take such action as the Government may direct as means of enforcing such provisions.
  - e. In no event will any amount of the assistance provided under this Contract be utilized with respect to a facility that has given rise to a conviction under Section 113(c)(1) of the Clean Air Act or Section 309(c) of the Federal Water Pollution Control Act.
11. **Historic Preservation.** This Contract is subject to the requirements of P.L. 89-665, the Archaeological and Historic Preservation Act of 1974 (P.L. 93-291), Executive Order 11593, and the procedures prescribed by the Advisory Council on Historic Preservation in 36 CFR Part 800. The City must take into account the effect of a project on any district, site, building, structure, or object listed in or found by the Secretary of the Interior, pursuant to 35 CFR Part 800, to be eligible for inclusion in the National Register of Historic Places, maintained by the National Park Service of the U. S. Department of the Interior, and must make every effort to eliminate or minimize any adverse effect on a historic property.
  12. **Historic Barriers.** This Contract is subject to the requirements of the Architectural Barriers Act of 1968 (42 U.S.C. 4151) and its regulations. Every building or facility (other than a privately owned residential structure) designed, constructed, or altered with CDBG funds must comply with requirements of the "American Standards Specifications for Making Buildings and Facilities Accessible to, and Usable by, the Physically Handicapped."
  13. **Lead-Based Paint.** This Contract is subject to the Lead-Based Paint Poisoning Prevention Act (42 U.S.C. 4821 et seq.), and Lead-Based Paint Regulations (24 CFR Part 35 and 24 CFR § 570.608 and/or 92.335), and related amendments thereto. The use of lead-based paint is prohibited whenever federal funds are used directly or indirectly for the construction, rehabilitation, or modernization of residential structures. All federally assisted residential structures and related property constructed prior to 1978, Homebuyer Programs, Tenant-Based Rental Assistance, and Special-Needs Housing (acquisition), will comply with existing and new Lead-Based Paint Hazard Reduction Requirements, effective September 15, 2000. As the Grantor or Participating Jurisdiction, the City of Glendale shall be consulted regarding the Agency/Grantee's compliance status.
  14. **Property Disposition.** Real or personal property purchased in whole or in part with CDBG funds shall not be disposed through sale, use, or location without the written permission of the City. The proceeds from the disposition of real property will be considered Program Income and subject to 24 CFR § 570.504(c).
  15. **Lobbying.** Block Grant funds shall not be used for publicity or propaganda purposes designed to support or defeat legislation proposed by federal, state, or local governments.
  16. **Acquisition/Relocation.** This Contract is subject to providing a certification that it will comply with the acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended, implementing regulations at 49 CFR Part 24, and 24 CFR Part 511.14, which govern the acquisition of real property for the project and provision of relocation assistance to persons displaced as a direct result of acquisition, rehabilitation, or demolition for the project.

17. **Section 504.** The Agency agrees to comply with any federal regulations issued pursuant to compliance with Section 504 of the Rehabilitation Act of 1973, which prohibits discrimination against the handicapped in any federally assisted program.
18. **Federal Fire Prevention and Control Act of 1992.** The Fire Administration Authorization Act of 1992 added a new Section 31 to the Federal Fire Prevention and Control Act of 1974. This Section requires that approved smoke detectors be installed in all houses assisted under the Community Development Block Grant Program. To comply with this requirement and locally adopted codes Agency shall install smoke detectors in all sleeping areas and any hallway connecting these sleeping areas.

## PROCUREMENT

1. The Agency agrees to comply with federal procurement requirements and the City's procurement code for all expenditures of funds. Below is an overview of the procurement requirements.
  - 1.1 Purchases over \$50,000 must be publicly bid.
  - 1.2 Purchases between \$10,001 and \$50,000 must follow competitive purchasing procedures based on written quotations.
  - 1.3 Purchases of \$5,000 to \$10,000, whenever practical, must be based on oral quotations, with file documentation of vendors contacted and quotations received.
  - 1.4 Purchases under \$5,000 do not require formal procurement.
  - 1.5 Expenditures for employee salaries or items such as client subsidies would not generally be subject to procurement requirements. (Such items do not generally constitute purchases.)
2. The Agency agrees to adopt a written procurement policy that, at a minimum, complies with the above procurement requirements, and to follow accounting procedures that will assure compliance with federal and city procurement codes.
3. The Agency further agrees to retain sufficient supporting documentation to demonstrate compliance with these requirements. Examples include, but are not limited, to the following:
  - 3.1 Copies of bid documents;
  - 3.2 Written quotations; and
  - 3.3 Evidence of oral quotations.

## DISPUTES/GRIEVANCE PROCEDURE

1. The Agency agrees to negotiate and resolve any disputes in the delivery of activities stated herein and will inform the City in writing of such negotiations and resolutions.
2. In the event the issue is not resolved, the City will confer with all parties to understand the issue, if appropriate, offer guidance, and try and reach an amicable solution.
3. In the event the issue is not resolved, and with both parties agreeing, the City Mediation Program will be available to assist in resolving the dispute.

## **RIGHT TO REFUSE SERVICE**

The City reserves the right to refuse, terminate, or suspend service or accounts to an individual, company, or agency, if the City believes that conduct or actions violate applicable law, is harmful to the interests of the City of Glendale and its affiliates, or meets the criteria covered under City's Right to Refuse Assistance Policy. 





## DRUG-FREE WORKPLACE

Employers of convicted employees must provide notice including position title, to every grant officer or other designee on whose grant activity the convicted employee was working, unless the Federal agency has designated a central point for the receipt of such notices. Notice will include the identification number(s) of each affected grant.
6. Taking one of the following actions, within 30 calendar days of receiving notice under paragraph 4.2, with respect to any employee who is so convicted:
  - 6.1 Taking appropriate personnel action against such an employee, up to and including termination, consistent with the requirements of the Rehabilitation Act of 1973, as amended; or
  - 6.2 Requiring such employee to participate satisfactorily in a drug abuse assistance or rehabilitation program approved for such purposes by a federal, state, local health requirements, law enforcement, or other appropriate agency.
7. Making a good faith effort to continue to maintain a drug-free workplace through implementation of the above-described paragraphs.
