In accordance with the Special Terms and Conditions, the above referenced contract is amended as follows:

1. The option to extend the term of the agreement is exercised this 26<sup>th</sup> day of January 2011. The term of the contract is hereby extended from April 1, 2011 through March 31, 2012, unless terminated, canceled or extended as provided within the contract.
2. Monthly rate for service shall be \$6,500 from April through June, 2011. Monthly rate for service shall be \$6,800 from July 2011 through March 2012.
3. Additional service to be added to the contract shall be kitchen cleaning service @ \$749.53 per service, on an "as required basis". Service shall include:
  - Deep clean and sanitize all stainless steel surfaces
  - Clean, degrease, and sanitize all appliances
  - Polish all stainless steel surfaces to a pristine condition
  - Thoroughly clean floor drains and remove any evidence of dirt/debris
  - Thoroughly clean all walls and remove all evidence of cooking-related debris
  - Move all mobile appliances, thoroughly clean inside, outside and underneath
  - Remove and thoroughly clean the overhead grease traps and filters
4. The existing insurance certificate is expiring on February 6, 2011 and a new certificate applying to the extended term is required and must be received by the City at that time. Please list the City of Glendale as Additional Insured on the Certificate of Insurance.
5. The present Performance Bond is expiring on March 31, 2011. A new bond is required at the expiration date in order to stay under contract with the City of Glendale.
