AMENDMENT NO. 3

DUPLICATING AND MAIL SERVICES AGREEMENT
(RFP # 12-39 Contract No. C-8129)

This Amendment for duplicating and mail services Agreement is made this 7th day of February, 2014 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and Novitex Enterprise Solutions, Inc. authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and Contractor previously entered into a Service Agreement, Contract No. C-8129, dated September 01, 2012 ("Agreement"); and
- B. City and Contractor previously modified the Agreement in Contract Amendment No. 1, extending the term of the agreement to August 31, 2014, and
- C. City and Contractor previously modified the Agreement in Contract Amendment No. 2, reassign vendor to Novitex Enterprise Solutions Inc. to acquire all of the Pitney Bowes Management Services, Inc. for the duplicating and mail services, and
- D. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT


In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of the contract is hereby extended from September 01, 2014 through August 31, 2015, unless terminated, canceled or extended as provided within the contract. All other provisions of the contract shall remain in their entirety.

With the extension of this agreement, a current insurance certificate is required. The certificate and policy shall name the City of Glendale as an additional insured and shall be primary coverage for the activity of the contractor.


3. **Scope Of Work.** The Scope of Work is unchanged.
4. **Compensation.** The compensation of the Agreement is unchanged and not to exceed \$500,000.00 for the new term.
5. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.




