AMENDMENT NO. 2

AGREEMENT FOR LANDSCAPE SPRINKLER AND IRRIGATION SERVICES
(City of Glendale Solicitation No. RFP 12-42, Contract No. C-8199)

This Amendment No. 2 ("Amendment") to the Agreement for Landscape Sprinkler and Irrigation Services ("Agreement") is made this 31 day of August, 2015 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and Mariposa Landscape Arizona, Inc., an Arizona corporation ("Contractor").

RECITALS

- A. City and Contractor previously entered into an Agreement for Landscape Sprinkler and Irrigation Services, Contract No. C-8199, dated October 16, 2012 ("Agreement"); and
- B. The Agreement had an initial two-year term beginning October 23, 2012 through October 22, 2014 and provided the option to extend for an additional three (3) years in one-year increments; and
- C. City and Contractor previously entered into Agreement Amendment No. 1, extending the term of the Agreement from October 23, 2014 through October 22, 2015; and
- D. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.


AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:


- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of the Agreement is extended for a one-year period from October 23, 2015 through October 22, 2016, unless otherwise terminated or canceled as provided by the Agreement. All other provisions of the Agreement except as set forth in this Amendment shall remain in their entirety.
- 3. **Scope of Work.** The Scope of Work is unchanged.

4. **Compensation.** The Compensation of the Agreement is unchanged and shall not exceed \$113,697.96 annually.
5. **Insurance Certificate.** The existing insurance certificate has expired and a new certificate applying to the extended term is required and must be received by the Contract Specialist prior to the execution of this Amendment.
6. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.




