AMENDMENT NO. 2

SUMMER CONCESSIONS AT THE FOOTHILLS RECREATION AND AQUATICS
CENTER AGREEMENT
(City of Glendale Solicitation RFP 13-31, Contract No. C-8463)

This Amendment No. 2 ("Amendment") to the Summer Concessions at the Foothills Recreation and Aquatics Center Agreement ("Agreement") is made this 20 day of May, 2015 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and Perfetto de Café, Inc., an Arizona corporation ("Contractor").

RECITALS

- A. City and Contractor previously entered into a Summer Concessions at the Foothills Recreation and Aquatics Center Agreement, Contract No. C-8463, dated May 14, 2013 ("Agreement"); and
- B. City and Contractor previously entered into Agreement Amendment No. 1, extending the term of the Agreement from May 14, 2014 through May 15, 2015; and
- C. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.


AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
2. **Term.** The term of the Agreement is extended for a one-year period from May 15, 2015 through May 14, 2016, unless otherwise terminated or canceled as provided by the Agreement. All other provisions of the Agreement except as set forth in this Amendment shall remain in their entirety.
3. **Scope of Work.** The Scope of Work is unchanged.
4. **Compensation.** The compensation of the Agreement shall remain as agreed to pay the city 26% of all gross revenue during the duration of the Agreement.

5. **Insurance Certificate.** The existing insurance certificate is expiring and a new certificate applying to the extended term is required and must be received by the Contract Specialist prior to the execution of this Amendment.
6. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.




