AMENDMENT NO.2

SHUTTLE OPERATIONS FOR STADIUM EVENTS
(City of Glendale Solicitation RFP 13-23, Contract No. C-8518)

This Amendment No. 2 ("Amendment") to the Shuttle Operations Services Agreement ("Agreement") is made this 18 day of June, 2015 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and SP Plus Corporation, a Delaware corporation authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and Contractor previously entered into a Shuttle Operations Services Agreement, Contract No. C-8518, dated June 25, 2013 ("Agreement"); and
- B. The Agreement had an initial one-year term beginning June 25, 2013 through June 24, 2014 and provided the option to extend for an additional four (4) years in one-year increments; and
- C. City and Contractor previously entered into Agreement Amendment No. 1, extending the term of the Agreement from June 25, 2014 through June 24, 2015; and
- D. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT


In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of the Agreement is extended for a one-year period from June 25, 2015 through June 24, 2016, unless otherwise terminated or canceled as provided by the Agreement. All other provisions of the Agreement except as set forth in this Amendment shall remain in their entirety.
- 3. **Scope of Work.** The Scope of Work is unchanged.
- 4. **Compensation.** The compensation of the Agreement is unchanged and shall not exceed \$3,000,000 for the entire term of this Agreement.

5. **Insurance Certificate.** The existing insurance certificate has expired and a new certificate applying to the extended term is required and must be received by the Contract Specialist prior to the execution of this Amendment.


6. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.


