**AMENDMENT NO. 12  
TO THE  
AGREEMENT OF MANAGEMENT, USE AND LEASE**

This AMENDMENT NO. 12 (the "Amendment"), dated as of July 25, 2013, to the Agreement of Management, Use and Lease (as amended, the "Agreement"), dated as of June 30, 2010 and as last amended as of January 30, 2013, by and among the City of Glendale, an Arizona municipal corporation ("City"), Coyotes Newco, LLC, a Delaware limited liability company ("Team"), and Arena Newco, LLC, a Delaware limited liability company ("Operator"), is made by and among the City, the Team, and the Operator. Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed to such terms in the Agreement.

WHEREAS, the parties hereto wish to amend the Agreement as set forth below.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:

1. Expiration Date. The parties hereto hereby amend Section 1 of the Agreement by deleting the definition of "Expiration Date" in its entirety and replacing it with the following:

"Expiration Date" means the earlier to occur of: (i) 11:59 p.m., Mountain Time, on August 6, 2013; provided, however, that if the Team and the Operator exercise their right to extend this Agreement pursuant to Section 3.4, the Expiration Date shall mean the last day of the Extension Period, and (ii) the date that this Agreement terminates pursuant to Section 6 hereof."

2. Interpretation. On and after the date hereof, each reference in the Agreement to "this Agreement", "herein", "hereof", "hereunder" or words of similar import shall mean and be a reference to the Agreement as amended and supplemented hereby.

3. Effectiveness. This Amendment is effective as of May 1, 2013.

4. No Other Amendments or Supplements to Agreement. Except as otherwise expressly provided herein, all of the terms and conditions of the Agreement remain unchanged and continue in full force and effect. Without limiting the foregoing, the rights of the Team and the Operator pursuant to Section 3.4 of the Agreement to extend the Term of the Agreement shall remain in full force and effect.


