**Amendment No. Two (2) to the 2013-14  
Independent Contractor Agreement  
Contract No. 07012013-14**

The Independent Contract Agreement dated July 1, 2013, and amended on January 17, 2014, between Arizona Community Action Association (ACAA) and **City of Glendale, an Arizona municipal corporation, through its Community Action Program** (hereinafter "City") to conduct application intake and eligibility determination for utility bill assistance and deposits is hereby amended as follows:

**Purpose of the Amendment:**

1. To allocate additional APS Crisis Bill Assistance funds in the amount of **\$8,518.00** (\$7,666.20 for direct service and \$851.80 for program delivery) in order to provide additional repair and replacement services to eligible families residing in the City of Glendale.

**Amendment to:**

Section I. Services and Programs – 1.2 Fund Sources:

**APS Crisis Bill Assistance Fund Source:** Increase direct service amount dollars from **\$5,000.00** to **\$12,666.20**, and program delivery dollars from **\$500.00** to **\$1,351.80**. The total amount of APS Crisis Bill Assistance funding increased from \$5,500.00 to \$14,018.00.

**Whole Agreement:**

Unless otherwise noted herein, all other provisions of the original Agreement will remain in place for the duration of the original Agreement.
