AMENDMENT NO. 1

BUS STOP POWER WASHING SERVICE AGREEMENT (RFP 13-53 Contract No. C-8676)

This Amendment for Bus Stop Power Washing Service Agreement is made to be effective the 23rd day of October, 2014 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and Triangle Services, Inc. an Arizona corporation authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and Contractor previously entered into a Service Agreement, Contract No. C-8676, dated October 23, 2013 ("Agreement"); and
- B. The original Agreement had an initial term of one-year beginning October 23, 2013 providing the option to extend the term for an additional four (4) years in one-year increments.
- C. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of the Agreement is extended for a one-year period from October 23, 2014 through October 22, 2015, unless otherwise terminated, canceled or extended as provided by the Agreement. All other provisions of the Agreement shall remain in their entirety.
- 3. **Scope of Work.** The Scope of Work is unchanged.
- 4. **Compensation.** The compensation of the Agreement is unchanged and not to exceed \$40,000.00 for the new term or not to exceed \$200,000.00 over a five year project period.

5. **Insurance Certificate.** The existing insurance certificate is expiring and a new certificate applying to the extended term is required and must be received by the Contract Specialist prior to the execution of this Amendment.
6. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.




