AMENDMENT NO. 1
BOARD UP SERVICES
(City of Glendale Solicitation IFB 13-22, Contract No. C-8715)

This Amendment No. 1 ("Amendment") to the Agreement for Board Up Services ("Agreement") is made this 26th day of June, 2015 to be effective the 4th day of November, 2014 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and Arizona Fire & Water Restoration, Inc., an Arizona corporation (Contractor).

RECITALS

- A. City and Contractor previously entered into Board Up Services Agreement, Contract No. C-8715, dated November 4, 2013 ("Agreement"); and
- B. The Agreement had an initial one-year term beginning November 4, 2013 through November 3, 2014 and provided the option to extend for an additional four (4) years in one-year increments; and
- C. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of the Agreement is extended for a one-year period from November 4, 2014 through November 3, 2015, unless otherwise terminated or canceled as provided by the Agreement. All other provisions of this Agreement shall remain in their entirety.
- 3. **Scope of Work.** The Scope of Work is unchanged.
- 4. **Compensation.** The compensation of the Agreement is unchanged and shall not exceed \$49,999 for full completion of all work required by the Project during the entire term of the Project.

- 5. **Insurance Certificate.** The existing insurance certificate has expired and a new certificate applying to the extended term is required and must be received by the Contract Specialist prior to the execution of this Amendment.

- 6. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.
