AMENDMENT NO. 1

INVITATION FOR BID (Contract No. C-8856)
City of Glendale Solicitation No. IFB 13-39

This Amendment to the Invitation for Bid is made this 17th day of March, 2014 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and DPC Enterprises, L.P., a Foreign Limited Partnership authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and Contractor previously entered into an Invitation for Bid, Contract No. C-8856, dated March 1, 2013 ("Agreement"); and
- B. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:


- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of the Agreement is extended for a one year period from April 9, 2014 through April 8, 2015, unless otherwise terminated or canceled as provided by the Agreement.
- 3. **Compensation.** Contractor's compensation is amended as of the Effective Date of this Amendment and Exhibit B of the original Agreement is amended as set forth in Exhibit B-Amendment No. 1, attached hereto.
- 4. **Insurance Certificate.** The existing insurance certificate is expiring and a new certificate applying to the extended term is required and must be received by the Contract Specialist prior to May 1, 2015.
- 5. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.


