AMENDMENT NO. 1

CONSTRUCTION AGREEMENT FOR LANDSCAPE SERVICES (Contract No. C-8931)

This Amendment No. 1 to the Construction Agreement for Landscape Services ("Agreement,") is made this 29 day of May, 2015 ("Effective Date,") by and between the City of Glendale, an Arizona municipal corporation ("City,") and Mariposa Landscape, Inc., an Arizona corporation ("Contractor,").

RECITALS


- A. City and Contractor previously entered into an Agreement for Landscape Services, Contract No. C-8931, dated May 28, 2014 ("Agreement,"); and
- B. The Agreement had an initial one-year term beginning May 28, 2014 through May 28, 2015; and
- C. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:


1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
2. **Term.** The term of the Agreement is extended on a month-to-month basis beginning May 29, 2015 through August 31, 2015, until terminated or cancelled as stated in the Agreement. All other provisions of the Agreement except as set forth in this Amendment shall remain in their entirety.
3. **Scope of Work.** The scope of work as described in Exhibit A is to be done every other week
4. **Compensation.** Contractor's compensation remains unchanged.
5. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.





EXHIBIT A

CONSTRUCTION AGREEMENT FOR LANDSCAPE SERVICES SCOPE OF WORK

(Contract No. C-8931)

Scope of Work:

Contractor will provide material, labor and equipment to mow and edge the turf of City properties located at the following:

1. Glendale homes located at 5215 West Ocotillo Road, Glendale, Arizona 85301
2. Cholla Vista Apartments located at 5320 West Maryland Avenue, Glendale, Arizona 85301
3. Lamar homes located at 6842 West Lamar Road, Glendale, Arizona 85301

Mowing will be performed using mulching mowers and weed eaters in areas unreachable with mowers.

Contractor will mow each property a total of 24 times a year with 22 mowing's to take place approximately every other week during the summer month per the City of Glendale's Community Housing Supervisor's coordination with Mariposa Landscaping, Inc., and two mowing's in the winter months.
