AMENDMENT NO. 2

AGREEMENT FOR LIBRARY COLLECTION SERVICES  
(City of Tempe Contract T12-001-01, Contract No. C-8949)

This Amendment No. 2 ("Amendment") to the Agreement for Library Collection Services ("Agreement") is made this 25 day of September, 2015, ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and Unique Management Services, Inc., a Kentucky corporation, authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and Unique Management Services, Inc., ("Contractor") previously entered into an Agreement for Library Collection Services, Contract No. C-8949, dated May 27, 2014 ("Agreement"); and
- B. The original City of Tempe Contract No. T12-001-01 had an initial two-year term beginning November 1, 2011 through October 31, 2013 and provided the option to extend for an additional three (3) years in one-year increments. The original City of Tempe Contract T12-001-01, as amended, expires October 31, 2016; and
- C. City and Contractor previously entered into Agreement Amendment No. 1, extending the term of the Agreement from May 27, 2014 through October 31, 2015; and
- D. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.


AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:


- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of the Agreement is extended from November 1, 2015 through May 27, 2016, unless otherwise terminated or canceled as provided by the Agreement. All other provisions of the Agreement shall remain in their entirety.
- 3. **Scope of Work.** The Scope of Work is unchanged.
- 4. **Compensation.** The compensation of the Agreement is unchanged and shall not exceed \$50,000 for the entire term of this Agreement.

5. **Insurance Certificate.** Current certificate will expire on December 15, 2015 and a new certificate applying to the extended term must be provided prior to this date to Materials Management and the Contract Administrator.
  
6. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.


