AMENDMENT NO. 1

(State of Arizona Contract No. ADSPO12-032930, Glendale Contract No. C-9450)

This Amendment No. 1 ("Amendment") to the Linking Agreement (Agreement) is made this 5 day of January, 2016 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City"), and Greenberg Traurig, LLP, an Arizona limited liability partnership authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and Greenberg Traurig, LLP ("Contractor") previously entered into a Linking Agreement, Contract No. C-9450, dated November 24, 2014 ("Agreement") pursuant to the State of Arizona Contract No. ADSPO12-032930; and
- B. The State of Arizona Contract No. ADSPO12-032930 had an initial one-year term beginning September 26, 2012 with the option to extend an additional four (4) years in one-year increments; and
- C. The State of Arizona Contract, as amended, expires on September 25, 2016; and
- D. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.


AMENDMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:


- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of this Agreement is unchanged. All other provisions of the Agreement and any Amendment thereto shall remain in effect in their entirety.
- 3. **Compensation.** The compensation of the Agreement is unchanged.

4. **Non-discrimination.** Contractor must not discriminate against any employee or applicant for employment on the basis of race, color, religion, sex, national origin, age, marital status, sexual orientation, gender identity or expression, genetic characteristics, familial status, U.S. military veteran status or any disability. Contractor warrants compliance with this section.
5. **Insurance Certificate.** Current certificate has expired and a new certificate applying to the extended term must be provided to Materials Management and the Contract Administrator prior to the execution of this amendment.
6. **Ratification of Agreement.** All other provisions of the Agreement and any Amendment thereto shall remain in effect in their entirety. If any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail and control.




