AMENDMENT NO. 1
TO
LINKING AGREEMENT BETWEEN
THE CITY OF GLENDALE, ARIZONA
AND
KELLY SERVICES, INC.

(State of Arizona Contract No. ADSPO13-043962, Glendale Contract No. C- 9910)

This Amendment No. 1 ("Amendment") to the Linking Agreement with Kelly Services, Inc. (Agreement) is made this 2nd day of April, 2016 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City) and Kelly Services, Inc., a Delaware corporation authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and Kelly Services, Inc. ("Contractor") previously entered into a Linking Agreement, Contract No. C- 9910, dated April 14, 2015 effective through April 1, 2016, pursuant to the State of Arizona Contract No. ADSPO13-043962, as amended; and
- B. The State of Arizona Contract, as amended, expires on April 1, 2017 and the City wishes to extend the term of the Agreement for a one-year period from April 2, 2016 through April 1, 2017; and
- D. City and Contractor therefore wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AMENDMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
2. **Term.** The term of this Agreement is extended for a one-year period from April 2, 2016 to April 1, 2017, unless otherwise terminated or cancelled as provided by the Agreement. All other provisions of the Agreement and any Amendment thereto shall remain in effect in their entirety.
3. **Compensation.** The compensation under this Agreement shall not exceed two hundred thousand dollars (\$200,000) annually or six hundred thousand dollars (\$600,000) for the entire term of this Agreement.
