Glendale Presiding Judge To Receive Award For Judicial Excellence Award. Glendale's Presiding Judge, Judge Elizabeth R. Finn, is the recipient of the Justice Michael D. Ryan Award for Judicial Excellence, presented by the State Bar of Arizona's Public Lawyers Section. This award was established in 1999 to honor a judicial officer who demonstrates a dedication and commitment to improving the justice system. This award is open to all federal, state and local judicial officers (including judges, commissioners, magistrates, hearing officers and justices of the peace) who have at least five years of judicial experience.

Judge Finn was nominated by the O'Connor House and their Avon Project for Women in Justice for her work with both organizations on domestic violence issues. The award will be presented during the State Bar's annual luncheon on Friday, June 21 at the Annual State Bar Convention at the Biltmore Resort in Phoenix.

Gallery Glendale Opens May 17 with Public Party. Westgate Entertainment District and the City of Glendale have finalized a year-long partnership to bring Glendale residents and Westgate patrons a free community art gallery and art, fitness and recreational classes. iStar Financial, owners of Westgate, are giving the City a 3,050 square-foot retail space next to Cold Stone Creamery, at no cost, which is valued at over \$100,000 annually. The space will house Gallery Glendale at Westgate, an art gallery featuring a sampling of Glendale's municipal art collection that will be open Fridays and Saturdays from 6- 9 p.m.

The city of Glendale and Westgate Entertainment District will present the unveiling party for Gallery Glendale at Westgate on Friday, May 17 from 6-9 p.m. This event is free and open to the public

The partnership includes the gallery and an array of classes and activities to include Story Time, Boot Camp, Zumba, CPR and First Aid Training, Glass Fusion Jewelry Making, Paint Along Party, Youth Hip Hop Dance and Youth Cheerleading.
