City of Glendale Budget Meetings. The city of Glendale conducted seven public budget meetings prior to the scheduled April 23 budget workshop.

The April 23 budget workshop will be held from 8:30 a.m. to 5 p.m. at Glendale City Hall in the Council Chambers. Free parking is available in the city hall parking garage. The meeting will be broadcast live on Glendale 11 TV and live online at www.glendaleaz.com/Glendale11. Notice of Potential Sales Tax, Property Tax and Business Fee Increases.

Property Tax

The City of Glendale will hold a public hearing on the property tax levy for Fiscal Year 2013 on June 12, 2012 and adopt the final property tax levy at a public meeting on June 26, 2012. The final levy amount may be increased over the approved levy for Fiscal Year 2012, which may result in an increase in the property tax rate.

TPT (Sales) Tax

As part of the City of Glendale's Fiscal Year 2013 budget, the City Council may consider an increase in the Transaction Privilege Tax (Sales Tax) rate. The Glendale City Council will hold a public hearing on June 12, 2012 to approve the City's Fiscal Year 2013 budget. At the same meeting the City Council may take action to approve a TPT (sales tax) rate increase.

Additional Bed Tax

As part of the City of Glendale's Fiscal Year 2013 budget, the City Council may consider an increase in the Additional Bed Tax Rate of 1.6%. The Glendale City Council will hold a public hearing on June 12, 2012 to approve the City's Fiscal Year 2013 budget. At the same meeting the City Council may take action to approve an additional Bed Tax rate increase.

Glendale Civic Center Fees

As part of the City of Glendale's Fiscal Year 2013 budget, the City Council may consider an increase to the fees for the Glendale Civic Center. The Glendale City Council will hold a public hearing on June 12, 2012 to approve the City's Fiscal Year 2013 budget. At the same meeting the City Council may take action to approve fees applicable to the Glendale Civic Center.

Glendale Parks and Recreation Fees

As part of the City of Glendale's Fiscal Year 2013 budget, the City Council may consider an increase to fees for Glendale Parks and Recreation. The Glendale City Council may take action to approve fees applicable to Glendale Parks and Recreation at the June 26, 2012 meeting.
