

***Re: Professional Management Services and Arena Lease Agreement-  
Notice of Arena Manager Assignment***

Dear Ms. Fischer, Mr. Bailey and Arena Manager:

This letter serves as notice to all Parties with respect to the assignment of the Team Owner's rights under the AMULA (hereinafter defined).

Reference is made to the Professional Management Services and Arena Lease Agreement (the "AMULA"), dated July 8, 2013, by and between the City of Glendale ("City"), IceArizona Manager Co., LLC now known as IceArizona Manager Co LP (the "Arena Manager"), and IceArizona Hockey Co., LLC now known as IceArizona Hockey Co LP (the "Team Owner"). Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to them in the AMULA.



Pursuant to § 12.1.3 of the AMULA, the Team Owner has the right to assign to any one or more lenders providing financing to the Team Owner, the entirety of its rights under the AMULA. Furthermore, pursuant to § 12.1.3(a) of the AMULA, the Team Owner must provide notice to the City and Arena Manager of such assignment within 30 days after such assignment becomes effective. While the City and Arena Manager already have constructive notice and knowledge of our assignment of rights to both Fortress Credit Co LLC ("Fortress") and the National Hockey League (the "NHL"), we nevertheless want to make sure you are provided with formal notice as required by the terms of the AMULA.

Notice is hereby given that pursuant to (1) the Leasehold Deed of Trust, Assignment and Security Agreement, dated August 5, 2013, and recorded August 5, 2013, as Instrument No. 2013-07102890 in the records of Maricopa County, Arizona, by Arena Manager and Team Owner for the benefit of Fortress; and (2) the Consent Nondisturbance and Recognition Agreement and Estoppel Certificate, dated August 5, 2013, and recorded August 5, 2013, as Instrument No. 2013-07102889 in the records of Maricopa County, Arizona, by and among the City, Arena Manager, Team Owner, and Fortress, the Team Owner has assigned the entirety of its rights under the AMULA to Fortress as security for Fortress providing financing to the Team Owner.

Notice is further given that pursuant to (1) the Leasehold Deed of Trust, Assignment and Security Agreement, dated August 5, 2013, and recorded August 5, 2013, as Instrument No. 2013-07102892, in the records of Maricopa County, Arizona, by Arena Manager and Team Owner for the benefit of the NHL (together with Fortress, each a "Team Owner Assignee"); and (2) the Consent Nondisturbance and Recognition Agreement and Estoppel Certificate, dated August 5, 2013, and recorded August 5, 2013, as Instrument No. 2013-07102891 in the records of Maricopa County, Arizona, by and among the City, Arena Manager, Team Owner, and the NHL, the Team Owner has assigned the entirety of its rights under the AMULA to the NHL as security for the NHL providing financing to the Team Owner.

Following receipt of this notice and pursuant to Section 12.1.3(c) of the AMULA, neither the City nor Arena Manager may enter into or consent to any amendment, waiver, modification or termination of the AMULA by agreement of the Parties to the AMULA without the prior written consent of both of the Team Owner Assignees.

Pursuant to § 12.1.4 of the AMULA, each of the City and Arena Manager shall, contemporaneously with giving any notice to the Team Owner under the AMULA, send a copy of such notice to each Team Owner Assignee and address it to each Team Owner Assignee at the addresses indicated above.
