Purpose


This is a request for the City Council to dedicate city-owned property for additional right-of-way for McLellan Road, from 59th Drive to 59th Avenue.



ORDINANCE NO. _____ NEW SERIES

AN ORDINANCE OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, ARIZONA, AUTHORIZING THE CITY MANAGER TO EXECUTE A DEDICATION OF ADDITIONAL RIGHT-OF-WAY FOR McLELLAN ROAD, 59TH DRIVE TO 59TH AVENUE IN THE CITY OF GLENDALE; AND ORDERING THAT A CERTIFIED COPY OF THIS ORDINANCE BE RECORDED.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GLENDALE as follows:

SECTION 1. That the City Council hereby authorizes the dedication of additional right-of-way for McLellan Road, 59th Drive to 59th Avenue and directs that the City Manager for the City of Glendale execute a Dedication of Right-of-Way in the form attached hereto as **Exhibit A**. The legal description is contained in the Dedication.

SECTION 2. That the City Clerk be instructed and authorized to forward a certified copy of this ordinance for recording to the Maricopa County Recorder's Office.
