

RESOLUTION NO. 4628 NEW SERIES

A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 6, 2012; DECLARING THE ELECTION OF THE MAYOR AND THREE COUNCILMEMBERS; AND ORDERING THAT A CERTIFIED COPY OF THIS RESOLUTION BE RECORDED.

WHEREAS, the City of Glendale General Election was held on Tuesday, November 6, 2012, for the purpose of (1) electing persons to the offices of Mayor and Councilmember in the Sahuaro, Cactus, and Yucca Districts; and (2) referring to the voters Proposition 457, an initiative submitted by petition proposing an amendment to Article VI, Section 7 of the Glendale City Charter relating to transaction privilege taxes (Save Glendale Now); and

WHEREAS, A.R.S. § 16-642 requires that the City council canvass the returns of the election not less than six days nor more than 20 days following the election; and

WHEREAS, the City Council having canvassed the returns of the General Election, finds the returns to be as stated in this resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GLENDALE as follows:

SECTION 1. That the results of the canvass having been determined, the official canvass of the City of Glendale's General Election held on November 6, 2012 is as follows:

- A. A summary of the number of ballots cast in each precinct for each candidate for Mayor, councilmember, and the proposition is shown in Exhibit A, which is attached and incorporated by this reference.
- B. A precinct group detail of the number of provisional ballots cast and the number of rejected ballots is shown on Exhibit B, which is attached and incorporated by this reference.
- C. A precinct group detail of the number of early ballots rejected and the reason rejected is shown in Exhibit C, which is attached and incorporated by this reference.

SECTION 2. That the total number of valid ballots cast at said General Election, as shown by the Precinct Canvass report was 69,558. (Exhibit A)

SECTION 3. That the total number of provisional ballots to be verified at said General Election, shown on Maricopa County's Provisional Ballots printout (Exhibit B) was 5,468. Of these 1,051 were found to be invalid.

SECTION 4. That the total number of early ballots rejected was 387. (Exhibit C)

SECTION 5. That the votes cast for the candidates for Mayor were as follows:

SECTION 8. The votes cast for Proposition 457, which amends Article VI, Section 7 of the Charter to provide that the Council shall have the power to levy a transaction privilege tax (sales tax) provided that no such tax shall be levied at a rate in excess of the rates specified, unless such rate is first approved by a majority of the qualified electors, were as follows:
