**V. Community Services Department Fee and Revenue Study Update – 20 minutes**

Summary: Staff will provide background and introduce the Norris Design consultant team to provide an update on the Community Services Department Fee Study.

**VI. Thunderbird Conservation Park Survey and Volunteer Initiative – 15 minutes**

Summary: For seven weeks this summer, Community Services Department intern, Stone Lieberman, will work on two Thunderbird Conservation Park projects. The first project focuses on creating, administering, and analyzing the results of an intercept survey at Thunderbird Conservation Park to better understand the opinions, wants and needs of park patrons. The second project focuses on developing a volunteer-led walking/hiking group program in Thunderbird Conservation Park to encourage increased use and connection to the park.

Upon completion of his internship, Mr. Lieberman will prepare a presentation of his findings and recommendations for the Parks and Recreation Advisory Commission. The purpose of this item is to update the Commission and answer any questions it may have.

Recommendation: For review and discussion.

**VII. Revised Dedicate-A-Bench/Tree Program Policy– 15 minutes**

Summary: The Community Services Department recently updated the policy for the Dedicate-A-Tree and Dedicate-A-Bench programs. These programs allow individuals or groups, the opportunity to honor a memory, individual or event by dedicating a tree and/or a bench in a Glendale park. Staff is seeking review and approval by the Commission regarding the updated policy.

Recommendation: For review and approval.

**VIII. Briefing on Murphy Park & Amphitheater Event Activities – 15 minutes**

Summary: In October 2015, staff received direction from the City Council to undertake a two-year pilot program to increase the use of Murphy Park and the City Hall Amphitheater, effective January 1, 2016. Now that the first six months have passed, staff will brief the Commission on its success to date.
